The main goal is to keep the connection between IT Solutions and business processes of different destination areas.

The Federative Republic of Brazil has received a loan from the International Bank for Reconstruction and Development - IBRD, which resources aim to support Bolsa Família Programme consolidation and the National Commitment for Social Development, and intends to use part of the loan amount to pay for Technical Consultancy specialized in Information Systems Projects to evaluate, diagnose and propose improvements in the management system of 'Bolsa Família' Programme (SIGPBF), focusing in its evolutive maintenance, identifying new scenarios, pointing improvement needs and stablishing verification and validation criteria of the functional applications designed by the Software Factory and others employees contracted by the Information Technology Board (DTI) of Social Development Ministry. The main goal is to keep the connection between IT Solutions and business processes of different destination areas.

The Ministry of Social Development and Fight Against Hunger, under the IBRD Loan Agreement 7841BR - Consolidation of the Bolsa Família Programme and support to the National Commitment for Social Development, invites specialized institutions/ firms to submit Expression of Interest for realize Technical Consultancy specialized in Information Systems to evaluate, diagnose and propose improvements in the management system of 'Bolsa Família' Programme (SIGPBF).
